



## Frequently Asked Questions

Question	Answer
Does it cost anything to work with Bridge?	No. There is <b>no fee</b> to request financing and no obligation to use Bridge. We are compensated by lending partners when a transaction closes.
What does Bridge primarily fund?	We support working capital, purchase order, inventory, equipment financing, accounts receivable financing, and traditional bank & SBA loans for growth.
How long does it take?	Terms are typically issued within approximately 48 hours after required documents are received. Funding timing depends on underwriting and transaction complexity.
What rates can I expect?	Rates vary based on order size, time to repayment, and the supplier's financial profile. Our direct lending and vetted network of lenders ensure highly competitive rates, keeping costs down for both suppliers and Best Buy consumers.
Will Best Buy see the details of my financing?	<b>No.</b> Bridge operates independently. Financing terms, pricing, and documentation remain confidential between the supplier and the lender. Best Buy is not a party to the financing agreement.
